# Aiuká & International Bird Rescue Working Agreement

### 1. Purpose of this document:

This document will provide a framework that will define the working agreement between Aiuká and the International Bird Rescue (Bird Rescue) and specify how both groups will work together during a Tier 3 oiled wildlife response in Brazil. For the purpose of this agreement, the effective date begins January 1, 2011 and is valid until such a time as either party terminates this agreement as per the "Effective Date" section of this agreement.

It is mutually recognized that Aiuká and International Bird Rescue have a common mission of providing assistance to animals in need and that by working together the two organizations can do more for animals than the sum of what could be achieved working independently. Aiuká recognizes certain areas of expertise that International Bird Rescue provides in oiled wildlife response, such as, contingency planning, management and rehabilitation; training expertise; media training and general wildlife rehabilitation. Specifically, International Bird Rescue has substantial experience and expertise in successfully managing large-scale oiled wildlife events. International Bird Rescue recognizes the unique expertise and capabilities that Aiuká brings to this joint effort, such as, a wide range of contacts from the fields of wildlife rehabilitation, federal wildlife agencies and the petroleum industry; local knowledge, as well as expertise in the field of oiled wildlife response and rehabilitation, logistical planning and implementation, in Brazil.

It is agreed that International Bird Rescue will work with Aiuká to respond to Tier 3 oil spills in Brazil, to provide oiled wildlife response management including hands-on wildlife rehabilitation, search and collection, data collection, volunteer management, media management, facility design and development, etc., as requested.

**Effective Date:** This Agreement is effective as of the first date above written and shall remain in effective unless cancelled by either party 30 days prior to the anniversary date of <u>January 1</u>.

## 2. Scope of Work:

#### SERVICES

International Bird Rescue Response Services: During the term of this Agreement, Bird Rescue will be available to perform oiled wildlife rescue, rehabilitation, documentation and other services associated with an oiled wildlife response on an assured response
