To acknowledge this Power of Attorney in the name of and as the act and deed of the Corporation; to register and record the same in the proper office or registry of any jurisdiction contiguous to or within the Caribbean Sea, South Atlantic Ocean or Gulf of Mexico, and to procure or proceed with any and every other act and thing whatsoever which may be in any way requisite or proper for authenticating and giving full effect to this Power of Attorney according to the law and usages of any jurisdiction, as fully and effectually as could the Corporation, for the purposes stated herein.

CONTRACT AMENDMENT

It is hereby agreed between the Clean Caribbean Corporation d/b/a Clean Caribbean & Americas ("CCA") and Petroleo Brasileiro S.A., ("Purchaser") that the provisions of the Clean Caribbean Corporation Sale Agreement, Contract No. C01-12, dated to be effective as of June 1, 2001, be amended as follows:

Article II, Paragraph 2.1 - Term - is hereby replaced with the following:

 Term. Subject to Section 9.13 hereof, this Agreement shall be effective as of September 1, 2006 and shall terminate on August 31, 2010 (the "Term"), unless earlier terminated pursuant to Sections 2.2 and/or 2.3 hereof.
